SAFETY NOTES

Safety Update AED Upgrades. Automated External Defibrillators (AEDs) are life saving devices that received nation attention when one was used to save the life of Buffalo Bills player Damar Hamlin. An AED is an easy-to-use medical device that can restore a normal heart rhythm to someone who has gone into cardiac arrest. The city maintains AEDs in all city facilities and is in the process of upgrading many devices with new Physio-Control LIFEPAK CR2 AEDs. These new AEDs have several innovative features, including a timesaving 'child mode' for delivering a lower-voltage shock with a single set of pads as well as wireless connectivity that enables the AED to perform automated self-checks. - **Energy Options Analysis** – OSI and 5Lakes Energy are deep in data analysis for the Energy Options Analysis. If all goes well, the team should be ready to share preliminary results in late Spring.
- **Commercial Solar** — OSI, in collaboration with the Ann Arbor 2030 District, is launching a new program to help commercial properties in the city and throughout Washtenaw County access the benefits of clean, renewable energy. The A2 Area Commercial Solar Program will provide one-on-one assistance to screen properties for solar potential, help with designing and releasing request for proposals to qualified installers, support in reviewing proposal responses and financial benefits, and help reviewing post-installation energy bills.
- **Transportation Survey** — OSI is continually working toward understanding and improving our community-wide greenhouse gas emissions in order to strive towards our goal of carbon neutrality. Ann Arbor's 2030 District has created a [transportation survey](#) that's being distributed throughout their partner network, which will help the city understand how changing work patterns have affected our greenhouse gas emissions. Seasonal Curbside Compost Collection Resumed Early. In ongoing efforts to provide storm-related branch collection, the City of Ann Arbor moved up regular curbside compost collection season by one week, which began on Monday, March 27, and will conclude on Friday, Dec. 8, 2023.

Staff also created a storm response dashboard that identifies areas that have been completed, areas where crews are actively working, and areas where crews will move to next. Please see <https://www.a2gov.org/stormresponse>

In addition, residents (not private contractors or landscapers) can bring material to the city compost facility, 4170 Platt Road, free of charge through the close of business, Monday April 17, 2023. The standard 1 cubic yard per day for-free limit will be waived during this time. For this drop off, the facility will be open Monday-Friday, 7 a.m.–4 p.m. and on Saturday 7–11 a.m. After April 17, the free 1 cubic-yard limit will be reinstated.

The City of Ann Arbor has extended its contract with Davey Tree Expert Company for continued storm-related cleanup. Davey's team will be focusing their resources on removing large brush piles from the curbside areas. Storm-related collection will be done in two parts, with crews collecting bundled branches and chipping larger branches separately.

There will be only one storm-related sweep through the city. Once storm related bundles of small and large branches are collected, crews will not be returning to the location to perform this service. Small bundles of branches can be prepared and picked up per normal compost rules.

Single-family residential properties can get one FREE 64- or 96-gallon compost cart by contacting customer service at 734.994.7336 or customerservice@a2gov.org. Pickup is free, or one can be delivered for \$56; additional carts are available for a fee. Visit www.a2gov.org/compost for sizes and prices.

Paper yard bags and bundled brush/tree limbs. Paper yard bags may be used for yard trimmings such as leaves, weeds and other vegetation (50 pound per bag weight limit). Bundled brush or tree limbs, 4 feet or less, can be tied with natural twine in bundles up to 18 inches in diameter, and left at the curb for pickup. Individual tree limbs must be less than 6 inches in diameter.

Participating residents must place their compostables at the curb before 7 a.m. on their weekly waste collection day — allowing at least 3 feet between each cart with clearance from any obstacles overhead. Carts should not be placed in lanes of travel, either roads or bike lanes, instead using yard extensions or buffer zones as directed.

Yard trimmings/waste must not be placed in parks because they may smother and kill plants they cover, disrupt normal decomposition processes, or introduce non-native plants to the area.

City of Ann Arbor Seeks Resident Input About Early Voting. With the approval of Proposition 2 in 2022, Michigan will be introducing nine days of early voting as another option for voters to conveniently cast ballots in statewide federal elections. The City of Ann Arbor is now asking for resident input as the city clerk's office prepares to implement early voting for the 2024 election cycle.

A six-question, anonymous survey has launched to help inform the city of how voters prefer to cast their ballots and their general awareness of the new early voting option. The survey can be found at https://communityfeedback.opengov.com/portals/annarbormi/Issue_12769 and is open through Monday, May 22, 2023.

“In light of these new changes coming, the City of Ann Arbor plans to use this feedback from city residents to make the voting process convenient, easy to understand and accessible to all who wish to cast a ballot,” said Ann Arbor City Clerk Jacqueline Beaudry. Early voting centers will allow voters to come early to vote and tabulate their ballots ahead of Election Day thereby eliminating long lines and wait times. This is a change from the previous system that only allowed early voting using an absentee ballot that was sealed in an envelope and not tabulated until Election Day.
