

It is now more important than ever that the infrastructure to operate drinking water and wastewater systems are adequately maintained and staffed to ensure these critical services are not interrupted. Identified as essential workers under both Governor Whitmer's Executive Order and by the federal Cybersecurity & Infrastructure Security Agency, water and wastewater system operators continue to work through the pandemic to ensure



safe water is delivered to the millions of Michigan residents and businesses that rely on municipal water systems and is collected and treated before discharged back into the environment by municipal wastewater systems.

The health and safety of these vital licensed

operators are critical to our single pathway to overcome this pandemic. In my utility, many of these workers are working long hours, to minimize the number of shift changes, away from their families

I am extremely proud of the utility workers who have staffed both our water and wastewater treatment plants, and those who have responded to distribution and collection issues since March. They are all working hard to ensure our basic needs are met during this crisis and deserve our thanks. If you see utility workers driving around in a City of Ann Arbor vehicle, please give them a thumbs-up in recognition of your appreciation for their commitment.

We hope that you, our customers, are both safe and healthy. Please know that no matter the challenges we may face, we are committed to providing you safe and reliable drinking water.

### **MAY WATER CHAMPIONS**

The City of Ann Arbor wants to thank everyone in our community who has heeded warnings to not flush wipes and who has taken the steps necessary

to maintain the functionality of private and public plumbing and sewer systems.



"Flushable wipes" create blockages in household pipes and municipal sewer systems and should never be flushed down the toilet, nor should facial tissue or paper towels.

Combined with fats, oil and greases, which should never be poured down the sink, these products can create enormous and expensive-to-remove,

"<u>fatbergs.</u>" In addition, to ensure that each household has enough toilet paper and stores are able to maintain a steady supply, everyone is encouraged to buy only what they need.

So please remember, no wipes in the pipes!
