RE: Traver Road (John A. Woods Drive – Barton Drive): Results of Final Polling

Dear Traver Road Residents and Owners,

Thank you for your interest in Traffic Calming on Traver Road. Following an initial questionnaire, orientation meeting, and self-guided tour meeting, a final poll was conducted to determine support for traffic calming within the project area.

The program guidelines specify that, “greater than 50% of returned final polls must indicate support (‘yes’) for the final plan”. This letter is to inform you that the results have been officially tallied and **the project has received enough support to move forward**. The breakdown of the final poll results are as follows:

- 20 Addresses in project area
- 10 Final poll responses received
- 10 Final polls supporting the final plan
- 100% Percent of final polls received support the final plan as shown.

The Traffic Calming Program has recently incorporated changes to align with the legislative resolution passed by Ann Arbor City Council in September 2023 regarding updates to the Traffic Calming Program. One of these updates is to remove the requirement to present Final Plans for individual Traffic Calming Projects to the Transportation Commission and City Council prior to consideration for construction. The full text is available on the city’s website, a2gov.legistar.com.

This project has met the required criteria to be considered for construction as funding becomes available and is tentatively planned to be completed during the 2025-2026 construction season. Notification will be provided to project area residents prior to work commencing.
