Description of Land Platted.

The land embraced in the annexed plat of Charles A. Ward's Subdivision is described as follows: Beginning at the South West corner of Elm St and Wilmot Street; thence westerly along the south side of Wilmot St 306.3 ft; thence deflecting to the left 90°00'00", 132 ft; thence deflecting to the right 40°47'30", 19.90 ft; thence deflecting to the left 90°01'30", 14.16 ft; thence deflecting to the left 89°58'30" 37.35 ft; thence deflecting to the right 59°11'30", 26.32 ft; thence deflecting to the right 42°34'30", 24.30 ft; thence deflecting to the left 42°34'30", 102.16 ft; thence deflecting to the left 90°00'00", 257.35 ft to the place of beginning, being a part of the east half of the S.W. 1/4 and the west half of the S.E. 1/4 of Section 28 Township 25, Range 6 E Meridian of Michigan.


