DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of Earhart Subdivision, a subdivision of part of the West 1/2 of Section 25 and the East 1/2 of Section 26, T2S, R6E, City of Ann Arbor, Washtenaw County, Michigan, is described as follows:

BEGINNING at the Northwest corner of Section 25, said point also being the Northeast corner of Section 26, T2S, R6E, City of Ann Arbor, Washtenaw County, Michigan; thence S 86°-41'-30" E 1320.14 feet along the North line of said Section 25 to a point on the Westerly right-of-way line of the U.
