Commencing at the northeast corner of North University Ave and State Street, running thence northerly along the east line of State Street, 91.80 ft to an iron stake from thence (deflection to the right 90° 15') running easterly 70.75 ft to an iron stake, from thence parallel to east line of State St 49.50 ft to a point in the north line of lots 7 and 8 Block 2 South Range 10 East, from thence easterly along said north line 42.87 ft to the northeast corner of lot 8, from thence southerly along the east line of said lot 8 144.50 ft to the north line of North University Ave., from thence westerly 121.58 ft along the north line of North University Ave to the place of beginning

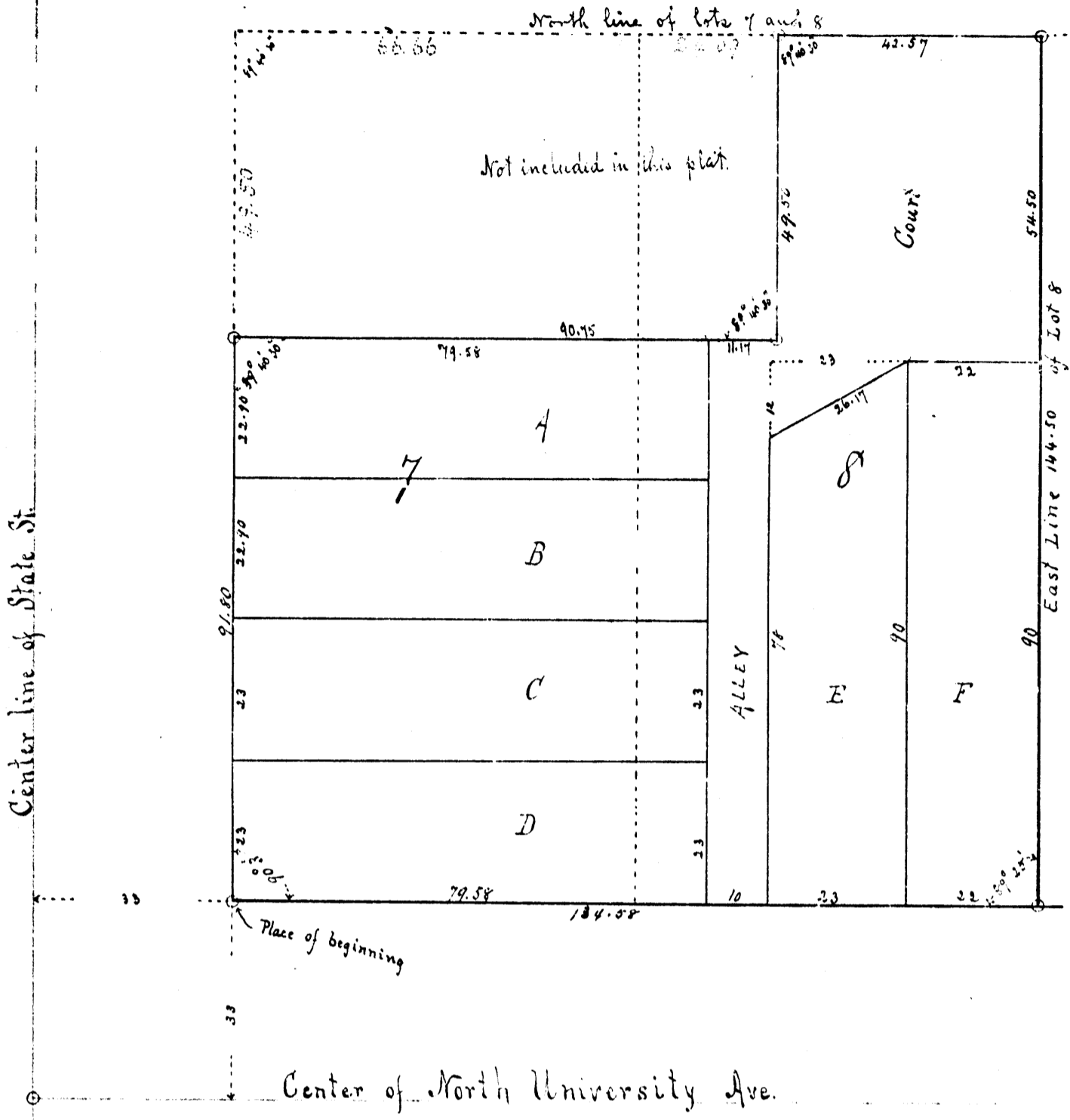
