1701-1747 Green Road, Ann Arbor, Washtenaw County

The Michigan Department of Environmental Quality (DEQ) has reviewed the Documentation of Due Care Compliance (DDCC), for 1701-1747 Green Road dated January 25, 2014 and received on January 29, 2014. The DDCC was submitted pursuant to Section 20114g (1) of Part 201, Environmental Remediation of the Natural Resources and Environmental Protection Act 1994 PA 451, as amended (NREPA). The DDCC proposes actions that are intended to comply with the requirements of Sections 20107a and the Part 10 Rules of the NREPA, which describe the due care obligations of the owner and/or operator of contaminated property. The due care obligations are designed to ensure that the use of contaminated properties protect health and safety of persons using that property, prevent exacerbation of the existing contamination, address the reasonable precautions to be taken against reasonably foreseeable acts or omissions of a third party in relation to the existing contamination, ensure that the effectiveness and integrity of land use or resource use restrictions are maintained and complied with, and ensure cooperation with persons authorized to conduct response activities on the property.

Based on our review, the DDCC is *approved*. This approval is based on the satisfactory implementation of the proposed actions presented in the DDCC including:

- Maintaining the western parking lot as an exposure barrier.
- Providing appropriate contamination notification to construction and utility workers who work sub-grade in the western parking lot area.

This approval is based on the information provided in the DDCC and the satisfactory implementation of the actions proposed in the DDCC to prevent or mitigate an unacceptable exposure, which cumulatively appear appropriate to achieve compliance with the requirements of Sections 20107a of the NREPA.

The owner and operator of this property may also have responsibility under applicable state and federal laws, including, but not limited to, Part 201, Environmental Remediation; Part 111, Hazardous Waste Management; Part 211, Underground Storage Tank Regulations; Part 213, Leaking Underground Storage Tanks; Part 615, Supervisor of Wells, of the NREPA; and the Michigan Fire Prevention Code, 1941 PA 207, as amended.

This approval is based on the information currently known to the DEQ Remediation and Redevelopment Division (RRD). The discovery of new information regarding environmental conditions or hazardous substances at the facility that is not known to the DEQ as of the date of this letter, or a change in property use, or a change in the Part 201 Criteria and Part 213 Risk Based Screening Levels (RBSLs) may necessitate that you re-evaluate and, if necessary, modify your due care obligations and response activities. If those conditions were not known to the DEQ as of the date of this letter, they may also result in a request by the DEQ for additional response activities.

Approval of this DDCC is not an acknowledgement that the property owner/operator was in compliance with the provisions of Sections 20107a of the NREPA prior to the date of this letter nor does it waive or release the property owner/operator from any obligations that may have existed prior to the date of this letter.
