Swimming Pool Chemicals

Bids Due: February 26, 2025 at 2:00 P.M. (Local Time)

The information contained herein shall take precedence over the original documents and all previous addenda (if any) and is appended thereto. **This Addendum includes five (5) pages.**

Bidder is to acknowledge receipt of this Addendum No. 1, including all attachments (if any) in its Bid by so indicating on page ITB-1 of the Invitation to Bid Form. Bids submitted without acknowledgment of receipt of this addendum may be considered nonconforming.

The following forms provided within the ITB document should be included in submitted bids:

- Vendor Conflict of Interest Disclosure Form
- City of Ann Arbor Non-Discrimination Ordinance Declaration of Compliance

Bids that fail to provide these forms listed above upon bid opening may be rejected as non-responsive and may not be considered for award.

I. QUESTIONS AND ANSWERS

The following Questions have been received by the City. Responses are being provided in accordance with the terms of the ITB. Bidders are directed to take note in their review of the documents of the following questions and City responses as they affect work or details in other areas not specifically referenced here.

Question 1: I can supply the suitable feeders. The bid does not specify installation. Is Ann Arbor interested in changing feeders and if so, who would be responsible for installing them?

Answer 1: If new chlorine feeders are required, the cost of the installation should be included in the bid. If so, please include the price for the installation of the required feeders and any associated costs.

Question 2: Are 60lb buckets acceptable? If so, can we bid on per LB rate or total quantity to make sure the bid is comparable?

Answer 2: If using a different quantity, please include a per pound rate and what a 50 pound bucket would cost, in order to fairly compare chemicals. See updated Bid Form attached hereto.

Question 3: How many deliveries per season do you expect to need?

Answer 3: We have 4 different pools and expect deliveries to each of the pools. There is not enough storage at each of the pools to store a full season's worth of chemicals. Plan on 2-3 deliveries per season to each pool.

- Question 4: Is it possible to deliver everything at the beginning of the season?
Answer 4: No. We do not have enough storage at each of the pools to store an entire season's worth of chemicals.
- Question 5: Regarding the request to add freight and delivery charges to the unit pricing of the bid (pg 7), am I able to add the item description "freight /delivery".
Answer 5: No. The pricing bid should include any freight or delivery charges.
- Question 6: Will Ann Arbor accept a bid for Cyanuric Acid in different quantities
Answer 6: If using a different quantity, please include a per pound rate and what a 20 kg bucket/bag would cost, in order to fairly compare chemicals. See updated Bid Form attached hereto.
- Question 7: What Chemical Feeders do the Ann Arbor pools currently have?
Answer 7: Ann Arbor has several different chemical feeders on it's various pools. It is expected that the winning bidder will supply chemical feeders that are compatible with the chemical that is supplied for all of the pools. We would like to have a consistent chemical feeder/ system across all of the pools.
- Question 8: Does the City of Ann Arbor want the chemical feeders/systems installed at each pool? If so, should the cost to install the chemical feeders/systems be included in the chlorine feeder price?
Answer 8: Yes. Total cost for chemicals and the feeder system will be taken into account when considering the submitted bids.
- Question 9: Does the City of Ann Arbor want feeders only or the complete feeder system (feeder and booster pump)?
Answer 9: The bid form has been updated for any costs associated with any needed for a complete feeder system to accommodate the Calcium Hypochlorite tablets bid. This price should include any equipment necessary for correct function of the chlorine tablets. Total cost will be taken into account when considering the submitted bids.

Bidders are responsible for any conclusions that they may draw from the information contained in the Addendum.
