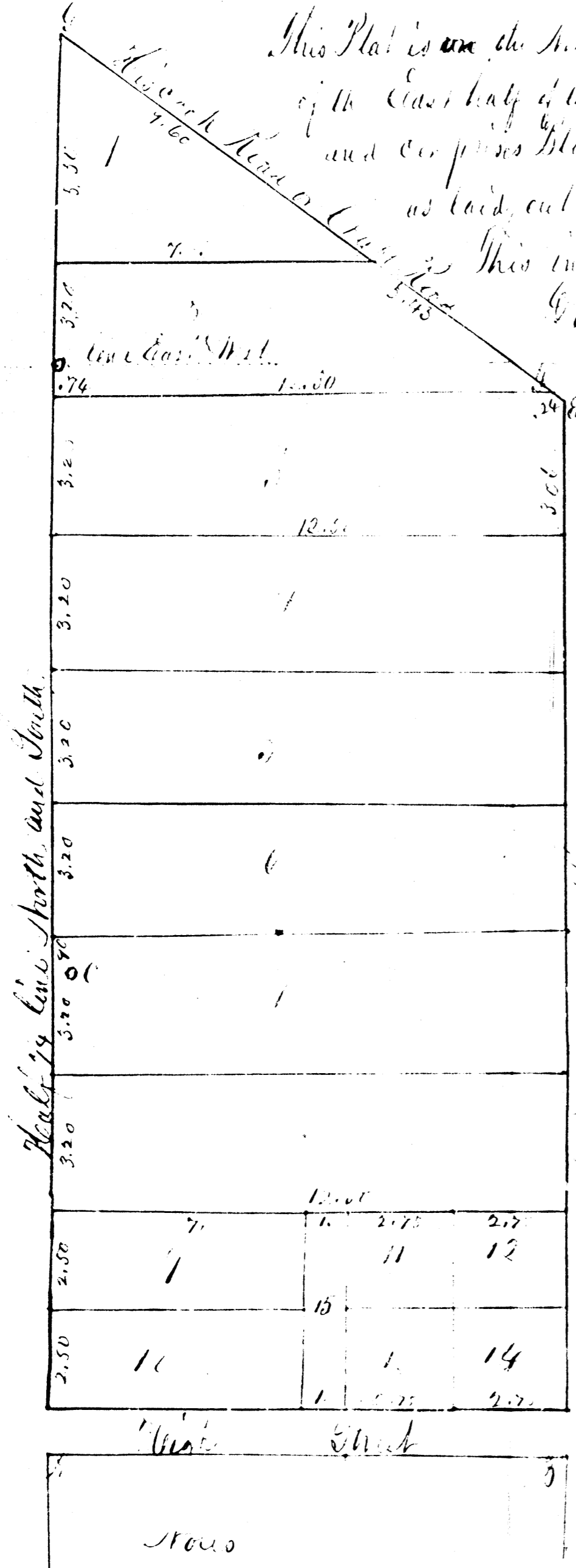


Wiscock's Improved Plat

This Plat is on the North West part of the East half of the South West quarter and the South West part of the East half of the North West quarter of Section 30 of Township Two South of Range Six, East 1- and comprises Blocks numbered 3, 4, 5, 8, 9 and 10 of Wiscock's addition to the City of Ann Arbor, as laid out and located in May A.D. 1859 in Liber number 45 on pages 160 and 161



This improvement or alteration, combining the above Blocks into one, by extending Front Street North of High St and Walnut Street West of Spring Street and dividing the Block into 15 lots as represented and numbered below. All lines are parallel and at right angles to the West line of the Plat, Field notes given by the Comps. Standing both East and South with West line. Distances given in Chains and links in small figures along the lines. The numbers of lots are given in this Plat near the middle of the same. J. Pelletine Surveyor
