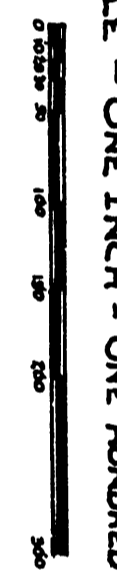
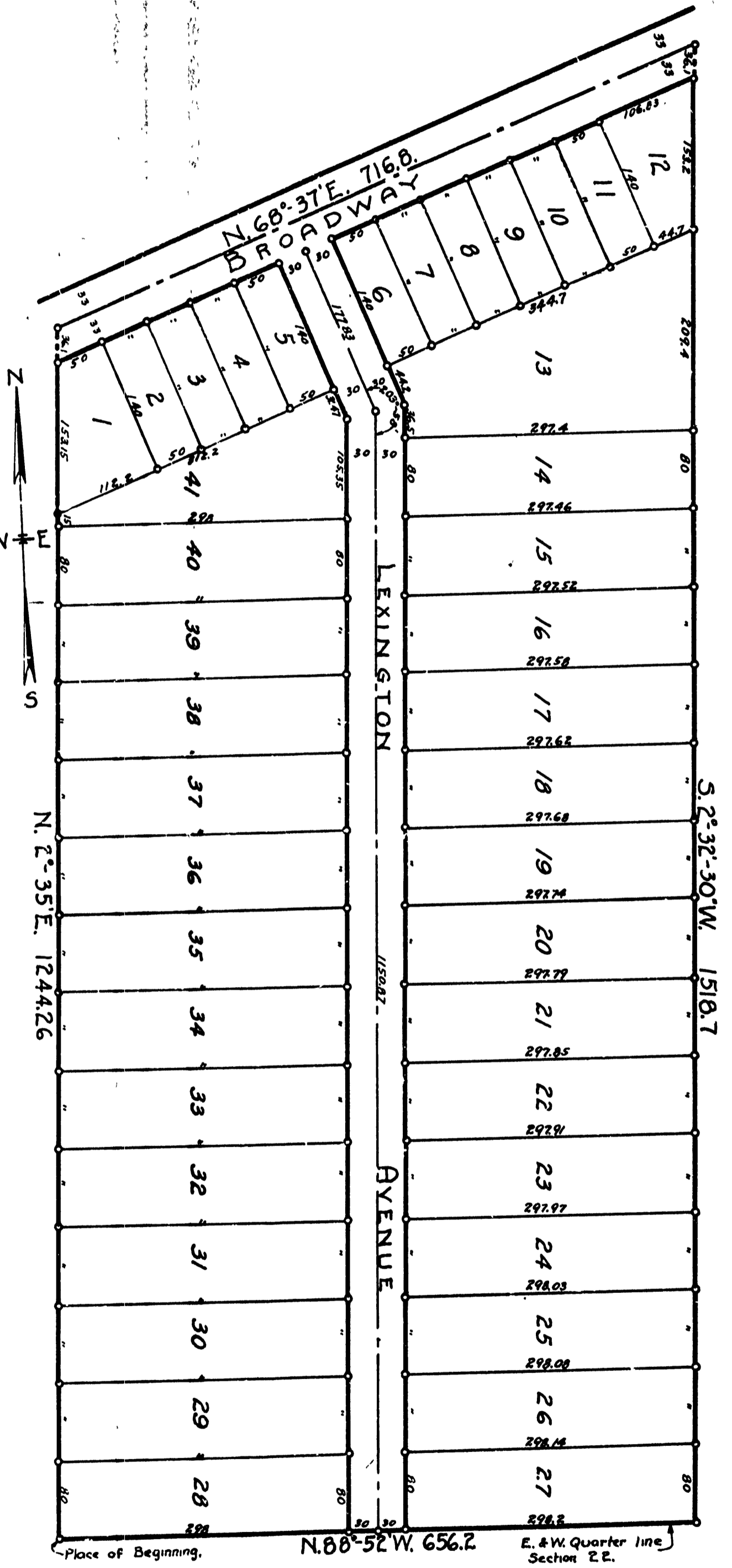


HILL CREST FARMS
