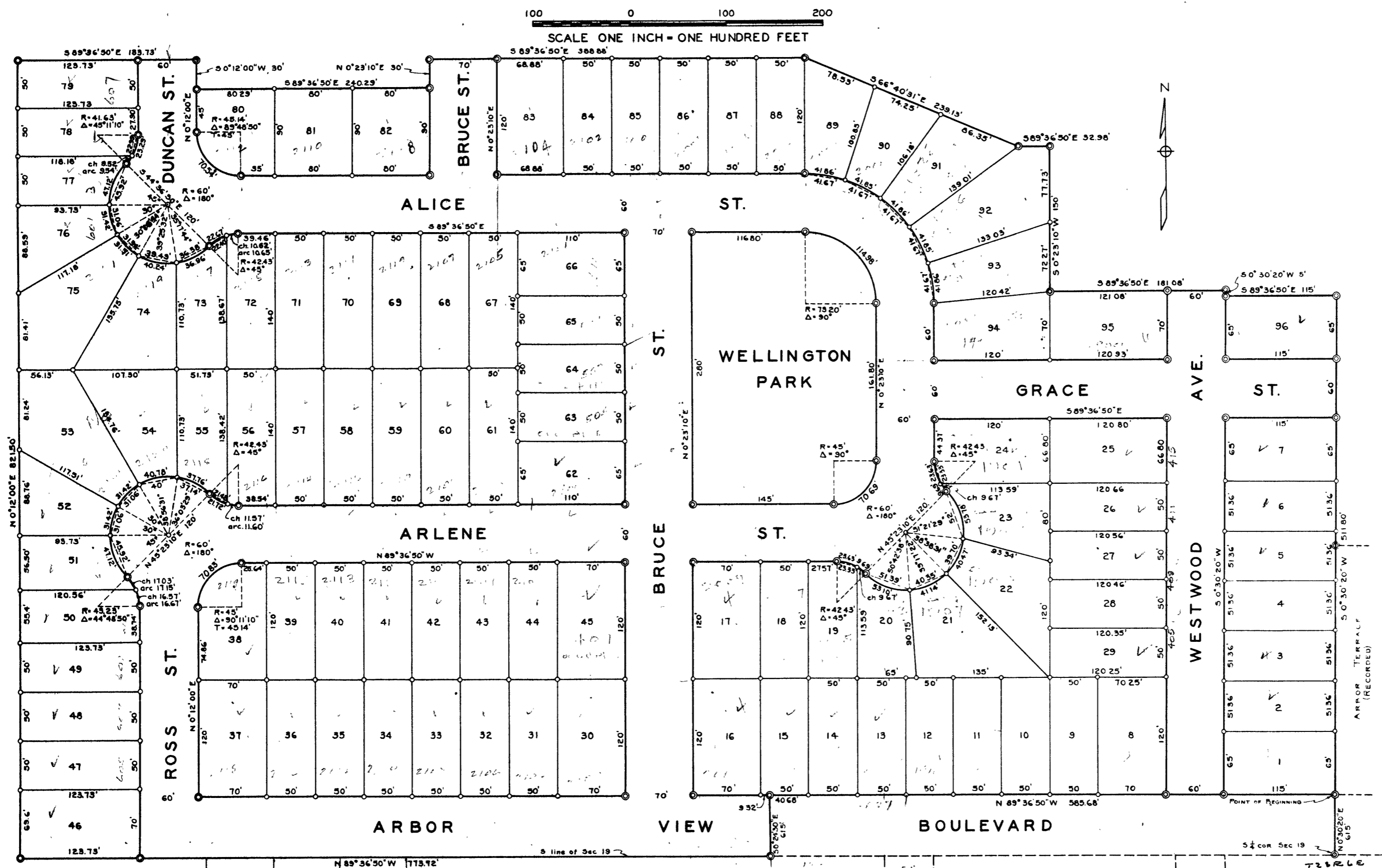

DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of "Arbor Heights" a part of
 the East half of the southwest quarter of Section 19, Town
 2 South, Range 6 East, City of Ann Arbor, Washtenaw
 County, Michigan,
 is described as follows:

Commencing at the south quarter post of Section 19, Town
 2 South, Range 6 East; thence N. 0° 30' 20" E. 61.5 feet in
 the north and south quarter line of said section for a place
 of beginning; Thence N. 89° 36' 50" W. 585.68 feet; thence
 S. 0° 24' 30" E. 61.50 feet to the south line of Section 19;
 thence N. 89° 36' 50" W. 773.72 feet in the south line of
 Section 19 to the West line of the east half of the south-
 west quarter of section 19; thence N. 0° 12' 00" E. 821.50
 feet; thence S. 89° 36' 50" E. 183.73 feet; thence S. 0° 12'
 00" W. 30.00 feet; thence S. 89° 36' 50" E. 240.29 feet;
 thence N. 0° 23' 10" E. 30.00 feet; thence S. 89° 36' 50" E
 388.88 feet; thence S. 66° 40' 31" E. 239.13 feet; thence
 S. 89° 36' 50" E. 32.98 feet; thence S. 0° 23' 10" W. 150.00
 feet; thence S. 89° 36' 50" E. 181.08 feet; thence S. 0° 30'
 20" W. 5.00 feet; thence S. 89° 36' 50" E. 115.00 feet; thence
 S. 0° 30' 20" W. 511.80 feet to the place of beginning.

SURVEYOR'S CERTIFICATE

 metal monuments consisting of bars not less than one-half inch in diameter and 48 inches
 in length, or shorter bars of not less than one-half inch in diameter lapped over each
 other at least 6 inches with an over-all length of not less than 48 inches, encased in a
 concrete cylinder at least 4 inches in diameter and 48 inches in depth have been placed
 at points marked thus (•••••) as thereon shown at all angles in the boundaries of the
 land platted, at all the intersections of streets, intersections of alleys, or of streets and
 alleys, and at the intersections of streets and alleys with the boundaries of the plat as
