

# SCHAIRER AND KEMPF'S ADDITION TO THE City of Ann Arbor, Washtenaw Co., Mich.


SECT. 32, T 2 S, R 6 E

The land embraced in the annexed plat of Schairer and Kempf's Addition to the City of Ann Arbor, Washtenaw Co., Mich., is described as follows:-  
Beginning at a point in the North line of Section 32, T 2 S, R 6 E, distant 676.96 ft West of the N E corner of said Section 32 and in the centre line of Hill St, thence East along said section line 406 ft to the intersection of Hill and Packard (or Grove) Sts; thence deflecting Southeast by 53°23'; and running along the centre line of said Packard (or Grove) St 89 ft, thence Southwesterly, at right angles, 165 ft, thence Westerly, by a line making an included angle with the line last described of 149°15'30", 332 ft to the centre of Sybil St, thence North, along the centre line of said Sybil St, and parallel to the East line W. of said Section 32, 204 ft, to the point of beginning, at the intersection of Sybil and Hill Sts.

I hereby certify that the plat hereon delineated is a correct one, and that permanent monuments consisting of iron pipe surrounded by stones have been planted at points marked thus  $\circ$ , as thereon shown, at all angles in the boundaries of the land platted, and at all intersections of streets or streets and alleys.
