The Streets are 4 rods wide. The lots are 4 rods wide and 8 rods long, excepting those which have their dimensions marked on the lot or block.

On this 30th day of May A D 1868, personally appeared before me a Notary Public for said Washtenaw County De Bolson Wood known true to be the person who signed the annexed certificate and acknowledged & declared that he is a Civil Engineer by profession, that he made & executed the annexed certificate that at the request of James B. Galt the proprietor within named he did survey the lands represented on the annexed plat & that said plat was made by him & is a true representation of the same as ascertained & surveyed and located on the ground.

Galt the Proprietor of the land upon which the annexed plat is located do hereby adopt & make the same my plat and dedicate the streets marked thereon to the public in pursuance of the Statute made & provided. And I do hereby require the Register of Deeds for the County of Washtenaw in the State aforesaid to record said plat & said Caroline M. Galt wife of the said James B. Galt do hereby assent to the said plat & release all my right to dower of in & to the streets laid down & dedicated therein in said plat. Whereof the said James B. Galt & Caroline M. Galt have hereunto set our hands and seals at the City of Ann Arbor this 30th day of May A D 1868.
