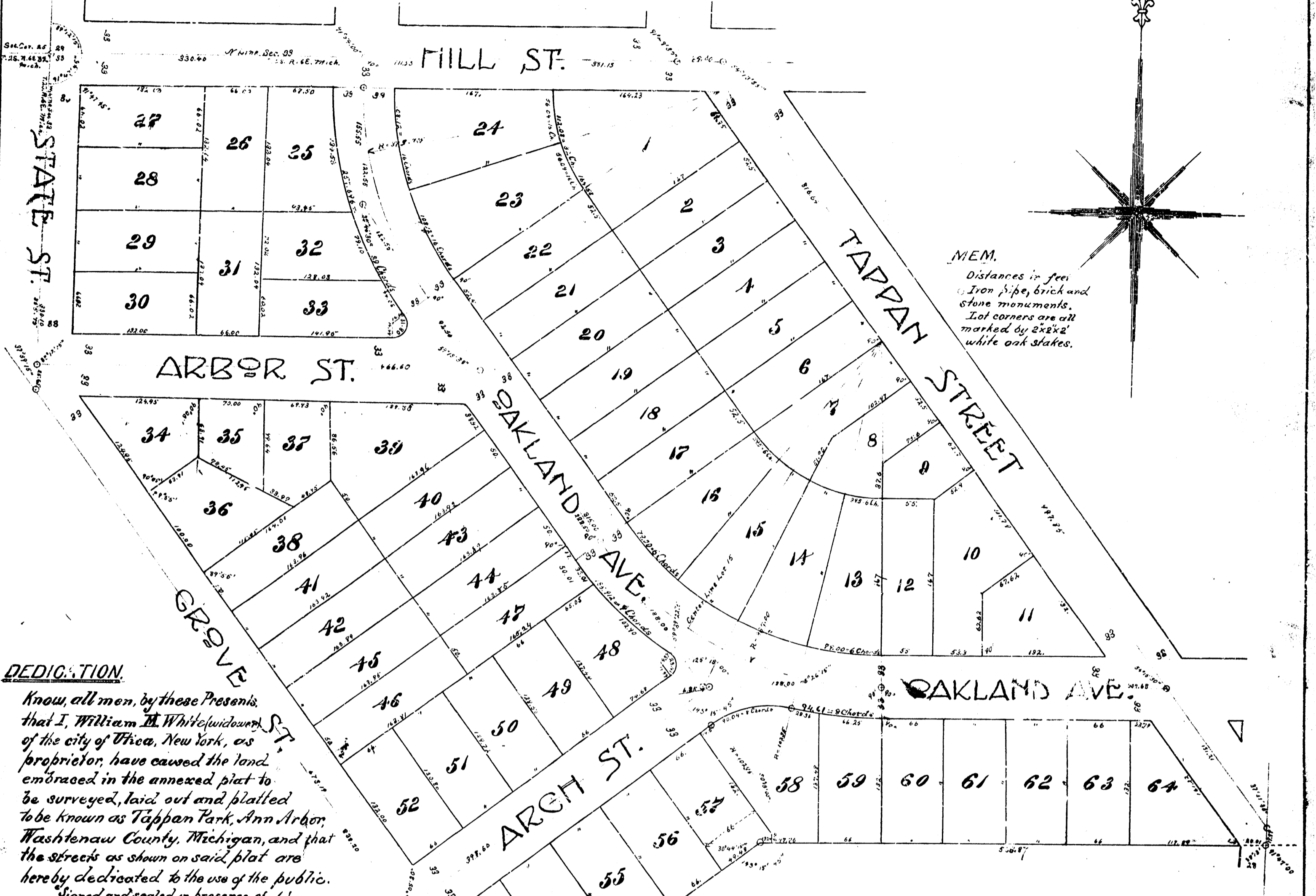


TAPPAN PARK ANN ARBOR MICH

DESCRIPTION.

Beginning at the corner of sections 28, 29, 32 and 33, in Township 2 South, Range 6 East, Meridian of Michigan; thence
 1. E. on Sec. Line 711.53 feet to center of Tappan St.
 2. S. E. by, deflecting 54° 13' 45" R. 997.85 feet in center of Tappan St. to monument line in E. University Ave.
 3. S. by, deflecting 37° 30' R. 17.99 feet on said line to S. W. corner of Block 2, Hills Addition.
 4. W. by, deflecting 88° 13' 00" R. 536.87 feet on S. boundary of Hills Addition produced W. by.
 5. S. W. by, deflecting 36° 44' 15" L. 346.40 feet to center of Grove St.
 6. N. W. by, deflecting 90° 54' 30" R. 838.20 feet in center of Grove St. to section line between 32 and 33.
 7. W. by, deflecting 37° 33' 15" R. 355.76 feet on section line to place of beginning.
 Subject to one half of Grove State, Hill and Tappan Sts. and 28 feet of E. University Ave. as shown on plat.
