**DEDICATION**  
NOW ALL MEN BY THESE PRESENTS, That we "DEXTER AVENUE HILLS LAND COMPANY" a Michigan corporation by Jay G. Pray President, and John F. Kilbourn Secretary as proprietor, and the "FARMERS AND MECHANICS BANK" a Michigan corporation by Herbert A. Williams President, and Fred T. Stowe Cashier as mortgagees, have caused the land embraced in the annexed plat to be surveyed, laid out and platted to be known as "DEXTER AVENUE HILLS", a subdivision of part of the west half of section 24, Scio Township, Washtenaw County, Michigan, and that the streets and alleys as shown on said plat are hereby dedicated to the use of the public.

### DESCRIPTION

The land embraced in the annexed plat of "DEXTER AVENUE HILLS" a subdivision of part of the west half of section 24, Scio Township, Washtenaw County, Michigan is described as follows: Commencing at the center of section 24, Town two south, Range five east, Meridian of Michigan; thence S. 87°-44' E. along the quarter line 1312.95 feet to the center line of Dexter Road, said course being the west line of the plat of "EVERGREEN LITTLE FARM" subdivision; thence N. 51°-13' W. along the center line of Dexter Road 27.31 feet; thence continuing along said center line N. 53°-24' W. 650.86 feet; thence N. 45°-07' W. 561.32 feet; thence N. 70°-37'-40" W. 45.12 feet; thence N. 1°-44' E. 818.15 feet to the east and west quarter line of said section 24; thence N. 87°-28' E. along said quarter line 171.9 feet; thence N. 1°-07'-30" E. 722.5 feet; thence S. 87°-56' E. 272.4 feet; thence N. 2°-04' E. 504.3 feet; thence S. 87°-28' E. 82.82 feet; thence N. 11°-06' E. 756.9 feet; thence S. 77°-45' E. 47.15 feet; thence S. 1°-45' E. 705.3 feet; thence S. 88°-16' E. 235.35 feet to an iron stake at 213.2 feet west of the north and south quarter line; thence S. 1°-44' E. 1203.5 feet to the east and west quarter line; thence S. 87°-28' E. along said quarter line 213.2 feet to the place of beginning.

### SURVEYOR'S CERTIFICATE
