# I. QUESTIONS AND ANSWERS

The following Questions have been received by the City. Responses are being provided in accordance with the terms of the ITB. Bidders are directed to take note in their review of the documents of the following questions and City responses as they affect work or details in other areas not specifically referenced here.

- Question 1: Is HMA removal, aggregate base, and hand patching to be paid for separately for line stops, or is it included in the pay item?
- Answer 1: Pavement Removal, 21AA Limestone and Hand Patching shall be paid for separately for all line stops.
- Question 2:Does the CL II Sand need to meet City of Ann Arbor specifications or just MDOT?Answer 2:MDOT specifications for CL II Sand are acceptable for this project.
- Question 3: Does the 21AA Limestone need to meet City of Ann Arbor specifications or just MDOT?
- Answer 3: MDOT specifications for 21AA Limestone are acceptable for this project.
- Question 4: Before work is done out in Main Street, does Third and Mosley streets have to be topped or can the traffic just drive on the base/leveling course?
- Answer 4: Traffic will be allowed to drive on the base/levelling course as work is being completed in Main Street. Phase 1 MOT signs will remain in place allowing local traffic only until the wearing course is placed on Third & Mosley.

- Question 5: Is there an estimated project value available yet?
- Answer 5: The Engineer's Probable Cost estimates the cost of the project to be \$1,600,000.00
- Question 6: Is there an Anticipated start date yet?
- Answer 6: We anticipate starting the construction as soon as the frost laws lift.
- Question 7: Is there a bid list (or planholders list) available yet?
- Answer 7: An unofficial list of plan holders from MITN/BidNet is included herein. This list attached is considered unofficial because the City does not track who picks up bid documents on just the City's website or through over avenues outside of MITN/BidNet.
- Question 8: Are there any Union requirements?
- Answer 8: Compliance with the City of Ann Arbor Prevailing Wage and Living Wage are required as mentioned within the ITB Document, but there are no specific requirements regarding involvement or lack of involvement with a union except as described in the Non-Discrimination Ordinance.
