**Bids that fail to provide these forms listed above upon bid opening will be rejected as non-responsive and will not be considered for award.**

## I. QUESTIONS AND ANSWERS

The following Questions have been received by the City. Responses are being provided in accordance with the terms of the ITB. Bidders are directed to take note in their review of the documents of the following questions and City responses as they affect work or details in other areas not specifically referenced here.

Question 1: Will the owner please confirm that the size of the line to be cleaned is 30 inch? The BF-1 Pay Item # 216 list it as 36 inch.

Answer 1: The correct size of the sewer line is 30 inch.

Question 2: Will the Owner please provide a current copy of the plan holders list?

Answer 2: An unofficial plan holders list and all available information (inclusive of any issued addenda) can be found through [MITN.info](http://MITN.info) and the [City's website](#).

Question 3: Will the Owner Except the debris from cleaning the sewer lines?

Answer 3: The Owner is not excepting any debris from the project. It is up to Contractor to find the proper way of disposing the material from sewer clean up.

Question 4: The Invitation to Bid for this project and it looks to be the same scope as the original project. Why this project is out for re-bid?

Answer 4: The apparent low bidder on the project made a verified error in bid pricing so the City determined that cancelling ITB# 4589 and reissuing as ITB# 4600 was the City's best course of action.

Question 5: Will the Owner please provide the budget for this project?

Answer 5: The Engineer's Estimate for this project is around 1.5 M.

Question 6: Will the Owner please provide the anticipated NTP date for this project?

Answer 6: The anticipated NTP date is listed in DS for Project Schedule and its November 15, 2019.

Question 7: Will the Owner/Engineer please confirm if there are any prevailing wage requirements for this job?

Answer 7: The prevailing wage document is included in the Contract Documents.
