

I hereby certify that hereon delineated is a correct one and permanent metal monuments consisting of bars not less than one-half inch in diameter and 48 inches in length, or shorter bars of not less than one-half inch in diameter lapped over each other at least 6 inches with an overall length of not less than 48 inches, encased in a concrete cylinder at least 4 inches in diameter and 48 inches in depth have been placed at the points marked thus @ as shown at all angles in the boundaries of the land platted, at all the intersections of streets and at the intersections of streets with the boundaries of the plat as shown on said plat.

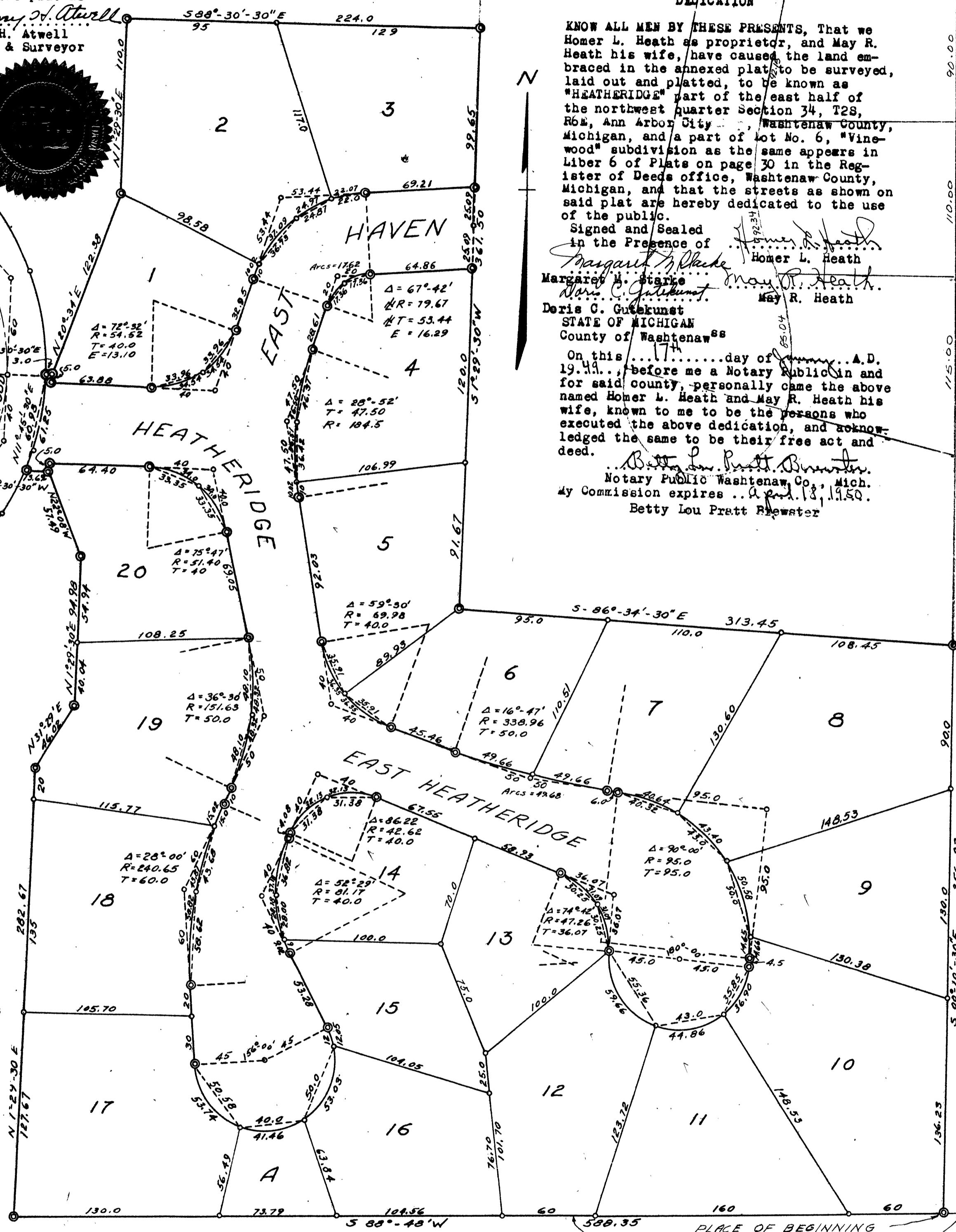

DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of "HEATHERIDGE" part of the east half of the northwest quarter of Section 34, T2S, R6E, Ann Arbor City, Washtenaw County, Michigan, and a part of Lot No. 6, "Vinewood" subdivision as the same appears in Liber 6 of Plats on page 30 in the Register of Deeds office, Washtenaw County, Michigan is described as follows: Commencing at a point in the north and south quarter line of Section 34, T2S, R6E, Ann Arbor Township, Washtenaw County, Michigan 824.1 feet south of the north quarter post of said section; thence south 88°-48' west 588.35 feet along the north line of "Tuomy Woods"; thence north 01°-29'-30" east, along the east line of "Vinewood" a subdivision of part of the southwest quarter of Section 27 and the northwest quarter of Section 34, Ann Arbor Township, Washtenaw County, Michigan, 282.67 feet; thence north 31°-29' east 46.02 feet; thence north 01°-29'-30" east 38°-30'-30" west 13.69 feet to the east line of "Vinewood" Boulevard; thence north along the east line of "Vinewood" Boulevard and in the arc of a circular curve, convex to the east, of the radius 171.97 feet a distance of 61.25 feet to the northwest corner of Lot No. 6 in "Vinewood"; thence south 85°-30'-30" east 3.0 feet; thence north 20°-34' east 122.38 feet; thence north 01°-29'-30" east 110.0 feet; thence south 88°-30'-30" east 224.0 feet; thence south 01°-29'-30" east 356.23 feet to the place of beginning; being a part of the northwest quarter of Section 34, Ann Arbor Township, Washtenaw County, Michigan.
