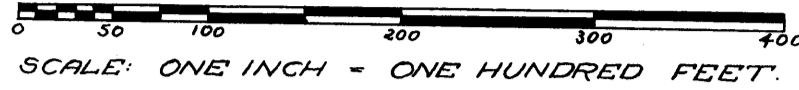

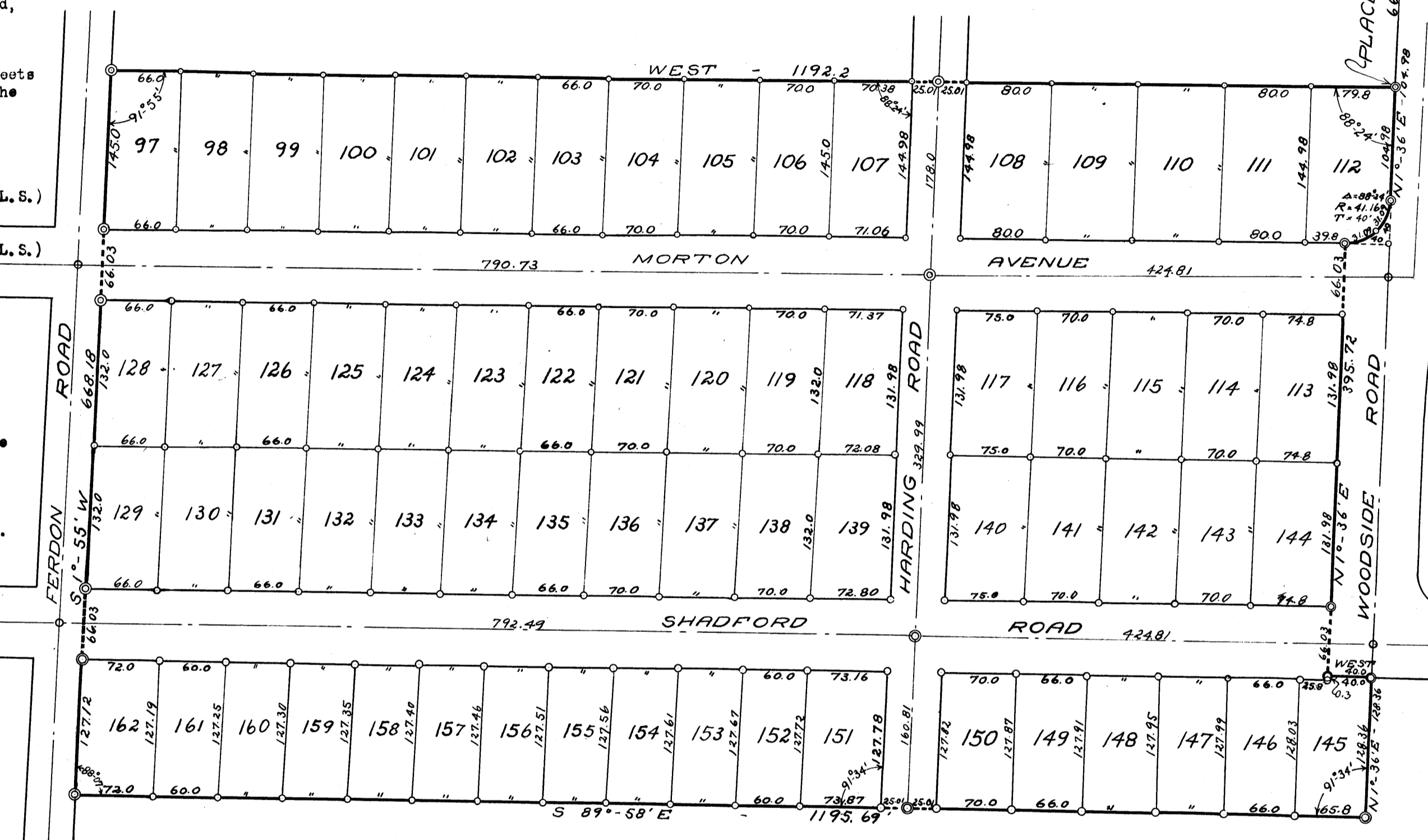
DESCRIPTION

The land embraced in the annexed plat of "W. H. Morton's Third Addition" a subdivision of part of the southeast quarter of section 33, Town two South, Range six East, in the City of Ann Arbor, Washtenaw County, Michigan, is described as follows:
 Beginning at a point in the east line of section 33, Town two South, Range six East, in the City of Ann Arbor, Washtenaw County, Michigan, 669.08 feet south of the east one quarter post of said section; thence west 1192.2 feet; thence south one degree and 55 minutes west 668.18 feet; thence south 89 degrees and 58 minutes east 1195.69 feet; thence north one degree and 36 minutes east 129.36 feet; thence west 40.0 feet; thence north one degree and 36 minutes east 395.72 feet; thence north-easterly in the arc of a circular curve to the left of radius 41.16 feet thru a central angle of 88 degrees and 24 minutes to a point in the east line of section 33; thence north one degree and 36 minutes east 104.98 feet to the place of beginning.

SURVEYOR'S CERTIFICATE.
